

# Swisher Electric Cooperative Scholarship Fund

Five scholarships are available in the amount of \$2,000.00 each with \$1,000.00 being applied per fall and spring semester for the 2023-2024 school year. Scholarships are subject to applicants' eligibility.

## Eligibility:

1. Scholarships are available to *active* Swisher Electric Cooperative *members* and immediate family members residing in their household; SEC *employees* and immediate family members residing in their household.
2. Scholarships to be granted to attend a recognized institution of higher education (college, technical school, or other post-secondary educational institution).
3. Applicant must be of good character as evidenced by at least one (1) letter from teachers, principals, counselors, etc., from the school they are attending OR from a minister, club sponsor, employer, etc. For applicants returning to school after an extended absence, letters will be accepted from previous employers, supervisors, ministers, etc.
4. Applicant must demonstrate a coherent degree plan and willingness to pursue a course of higher learning.
5. Applications must be *received* no later than Monday, March 6, 2023.
